Subject: Extension of timeline for filing of Annual Returns till 30th September, 2026 under the E-Waste (Management) Rules, 2022- reg.

This has reference to the letter dated 10th August, 2026 received from the Central Pollution Control Board (CPCB) stating that CPCB has received requests from producers and recyclers for extending the time line for filling/submission of respective Annual Return/Report for Financial Year 2025-26 due to operational and technical challenges in timely compilation and reconciliation of compliance related data for submission through the centralized EPR Portal under the E-Waste (Management) Rules, 2022 beyond 30th April 2026.

2. CPCB has requested Ministry to extend timeline for filling quarterly and annual returns till 30th September, 2026 for Financial Year (FY) 2025-26.
3. The matter has been examined in the Ministry and in accordance with the Rule 9A of the E-Waste (Management) Amendment Rules, 2024, Ministry hereby extends the timeline for filing of annual returns by the producers and recyclers till 30th September, 2026 for FY 2025-26.
