No. 610107-FS&CA-2026/5195.—With reference to Chandigarh Administration Department of Food & Supplies and Consumer Affairs & Legal Metrology notification No. L.M./2026/4405 dated 22.05.2026 and in exercise of the powers conferred by sub-section (1) of Section 53 of the Legal Metrology Act, 2009, the Administrator, Union Territory, Chandigarh is pleased to amend the Chandigarh Legal Metrology (Enforcement) Rules, 2011 issued by the Chandigarh Administration vide Notification bearing No. 4/4/21-HII(3)-2011/16450 dated 12.09.2011 ;

THE CHANDIGARH LEGAL METROLOGY (ENFORCEMENT) (2nd AMENDMENT)

RULES, 2026

1. **Short title, extent and commencement** – (1) These rules may be called the Chandigarh Legal Metrology (Enforcement) (2nd Amendment) Rules, 2026.
2. They shall come into force on the date of their publication in the Official Gazette of Chandigarh Administration.

2. In Rule 15 of The Chandigarh Legal Metrology (Enforcement) Rules, 2011 (hereinafter referred to as ‘principal rules’), after sub rule (1), the following sub-rules shall be inserted as follows:

1(a) Verification and stamping of low risk weights and measures as specified in Schedule XII shall be made on the basis of submission of self-certification by the applicant in Form A of Schedule XIII.

1(b) Verification and stamping of Medium risk and High risk weights and measures as specified in Schedule XII shall also be made on the basis of submission of third party certification from licensed repairer as specified in Form B of Schedule XIII (Third-party herein means repairer who possesses *bona fide* license issued by the Controller)

3. **Insertion of Schedule – XIII:** - In the principal rules, Schedule- XIII shall be inserted as under: -
