MOTOR VEHICLE ACT, 1988.

G/PT/2025/28/PTD/MRT/e-file/22/2024/0611/KH: WHEREAS certain draft rules further to amend the Gujarat Motor Vehicles Rules 1989, were published as required by sub-section (1) of section 212 of the Motor Vehicles Act, 1988(59 of 1988), at page 98-1 to 98-2 of Gujarat Government Gazette, Extraordinary, Part-IV-A, dated 5th July, 2025 under the Government Notification, Ports and Transport Department No:G/PT/2025/21/PTD/MRT/e-file/22/2024/0611/KH, dated 5th July, 2025, inviting objections or suggestions from all persons likely to be affected thereby for a period of thirty days from the date of publication of the said notification in the *Official Gazette*;

AND WHEREAS no objection or suggestion has been received by the Government in respect to the said draft notification;

NOW, THEREFORE, in exercise of powers conferred by sub-section (7) of section 47, sub-section (4) of section 49 and sub-section (5) of section 50 of the Motor Vehicles Act, 1988 (59 of 1988), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Motor Vehicles Rules, 1989, namely:-

1. (1) These rules may be called the Gujarat Motor Vehicles (2nd Amendment) Rules, 2025.
(2) They shall come into force from the date of their final publication in the *Official Gazette*.
2. In the Gujarat Motor Vehicles Rules, 1989, for the rule 44A, the following rule shall be substituted namely:-

“44A. Amount of lieu of action for certain failure:-The amount payable by any person in lieu of action for failure to make an application under sub-section (1) of section 47, or failure to intimate under sub-section (1) of section 49, or failure to report or apply under clause (a) or clause (b) of sub-section (1), or as the case may be, under sub-section (2) of section 50 shall be as follows:-

Sr. No.	Provisions of Motor vehicle Act, 1988.	Amount
1	Sub-section (1) of section 47 read with section 47(5)	Rs.100/-
2	Sub-section (1) of section 49 read with section 49(2)	Rs.500/-
3	Clause (a) or clause (b) of sub-section (1), or as the case may be, under sub-section (2) of section 50 read with section 50(3)	Rs.100/-
