G.S.R.90 .-Whereas the draft of the Rajasthan Motor Vehicles (Draft Amendment) Rules, 2025, amending the Rajasthan Motor Vehicles Rules, 1990, in exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), was published as required by sub-section (1) of section 212 of the said Act in the Rajasthan Gazette Extraordinary Part 4(ga) dated 24.09.2025 inviting objection and suggestion from all persons likely to be affected thereby before the expiry of fifteen days from the date on which the copies of the said notification as published in the Rajasthan Gazette were made available to the public;

And whereas, copies of the said notification were made available to the public on 24.09.2025;

And whereas, no objection and suggestion has been received from the public in respect of the said draft rules by the State Government;

Now, therefore, in exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), the State Government hereby makes the following rules further to amend the Rajasthan Motor Vehicles Rules, 1990, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Motor Vehicles (Third Amendment) Rules, 2025.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Substitution of rule 7.85.- The existing rule 7.85 of the Rajasthan Motor Vehicle Rules, 1990 shall be substituted by the following, namely:-

“7.85 Colour.- The colour of vehicles shall be such as specified, from time to time, by the Transport Commissioner, District Magistrate or Police Commissioner, as the case may be.”
