NOTIFICATION

In exercise of the powers conferred under sub-section (2) of Section 3 of the Andhra Pradesh Factories and Establishments (National, Festival and Other Holidays) Act, 1974 (Act No.32/1974) and Andhra Pradesh Shops and Establishments Act, 1988 (Act 20/1988) read with the provisions laid down in Section 135-B of the Representation of the Peoples Act, 1951 and in pursuance of the orders issued vide reference cited supra, Government of Andhra Pradesh hereby declares paid holiday on the day of poll for Legislative Assemblies of Tamil Nadu and Puducherry, 2026 i.e. (09.04.2026 for Puducherry and 23.04.2026 for Tamil Nadu) to the persons employed in any business trade, Industrial undertakings or any other

shops and establishments who are electors of respective States and working in neighbouring Districts of Andhra Pradesh i.e., Kakinada, Dr.B.R.Ambedkar Konaseema, Tirupati and Chittoor Districts, with regard to the Industrial Undertakings / Establishments so as to enable the workers to exercise their franchise.

2. The Commissioner of Labour, Andhra Pradesh, Vijayawada and the Director of Factories, Andhra Pradesh, Vijayawada shall take further action accordingly.
