ORDER:

The Election Commission of India has notified 06.10.2026 (Tuesday) as the poll day for the Bye-Election to Tamil Nadu Legislative Assembly from 35.Madurantakam (SC) and 101.Dharapuram (SC) Assembly Constituencies in Chengalpattu and Tiruppur districts respectively. Hence, the poll day 06.10.2026 (Tuesday) has to be declared as public holiday under section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881).

2. The following Notification shall be published in an extra-ordinary issue of the Tamil Nadu Government Gazette dated:18.09.2026.

Notification

Under the "Explanation" to Section 25 of the Negotiable Instruments Act, 1881 (Central Act, XXVI of 1881) read with the Notification of the Government of India, Ministry of Home Affairs No. 20-25-26, Public-1, dated the 8th June 1957, the Governor of Tamil Nadu hereby declares Tuesday, the 06th October 2026, the date on which the poll for the Bye-Election to Tamil Nadu Legislative Assembly from 35.Madurantakam (SC) and 101.Dharapuram (SC) Assembly Constituencies will take place, in the areas comprised in the above said Assembly Constituencies lying in Chengalpattu and Tiruppur districts respectively, to be a Public Holiday.

2. Further, all employees working in Chengalpattu and Tiruppur districts and neighbouring districts but registered as voters in 35.Madurantakam (SC) and 101.Dharapuram (SC) Assembly Constituencies, shall also be given a paid holiday on 06.10.2026.

All the Government offices including industrial establishments of the Government and Government controlled bodies and all the educational institutions throughout the area comprised in 35.Madurantakam (SC) and 101.Dharapuram (SC) Assembly Constituencies lying in Chengalpattu and Tiruppur districts respectively will remain closed on 06.10.2026.
