Notification

Whereas, there is a need for simplification of procedures for hassle free statutory clearances for rapid industrialization in the State of Tripura and the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India has recommended in Business Reform Action Plan-2026 to ensure submission of self-attested documents, wherever applicable, instead of affidavits or notarized documents for obtaining clearances on fulfilling compliance requirements.

Now, therefore after careful consideration of the matter, the State Government has decided to adopt submission of self-attestation in lieu of affidavits or notarized documents for obtaining No-objection certificates (NoC) from the Department with immediate effect.

Self-certified / Self-attested documents will be accepted under the Factories & Boilers Organisation, Government of Tripura for the following approvals & services:

1. New Factory Plan Drawing Approval.
2. Approval for Revised Plan Drawing of existing Factory.
3. Registration of Establishment (Factory).
4. Grant of Factory License.
5. Renewal / Auto renewal of Factory Licence.
6. Amendment Factory License.
7. Approval for Closure of factory.
8. Approval for Re-opening of factory.
9. Submission of Online Return.
10. Other services- i) Selection of Competent Person ii) Third Party Registration etc.
11. Approval of New Boiler Registration.
12. Renewal of Boiler Certificate.
13. Approval of Boiler Erectors / Repairers.
14. Renewal of Boiler Erectors / Boiler Repairers.
15. Endorsement of Boiler Erectors / Repairers.
16. Endorsement IBR Welder
17. Approval for Steam Pipeline Erection.
18. Approval of Boiler Feed Pipe Line.
19. Approval of Boiler Manufacturers.
