Explanatory Note

(This does not form the part of the notification, but is intended to indicate its general purport.)

The Central Government, vide G.S.R. (850)(E) dated 11th November, 2025, has amended rule 81 of the Central Motor Vehicles Rules, 1989, enhancing the fee for renewal of the certificate of fitness for certain age categories of vehicles. In view of several representations from motor transport associations stating that the revised fee is exorbitant and imposes an undue financial burden on operators, particularly in the public transport sector where a large number of vehicles are over 15 years old and taking into account the fact that the steep increase is likely to affect the operational viability of transport operators and may adversely impact the general public who rely on public transport services. Hence the Government have decided to reduce the enhanced fee.

The notification is intended to achieve the above object.
