OFFICE ORDER

This is in reference to the letter dated 08.01.2026 issued by Secretary, Ministry of Labour, Secretary (Ministry of Panchayati Raj) and Secretary (Ministry of Housing & Urban Affairs) which relates to Special Registration Drive for Pradhan Mantri Shramyogi Maandhan Scheme and NPS-Traders Scheme during the period 15.01.2026 to 15.03.2026. During this period, registration camps are to be organized and daily progress report of registration has to be shared with Ministry of Labour & Employment in the specified proforma (copy enclosed).

PM-SYM (Pradhan Mantri Shram Yogi Maandhan) is a voluntary Government of India pension scheme for old-age social security for unorganized workers, offering a minimum assured pension of ₹3,000 per month after age 60, funded by monthly contributions from eligible workers (18-40 years old, earning up to ₹15,000/month) and matching government funds.

The NPS-Traders contribution is a co-contributory pension scheme where the trader pays a monthly amount (Rs. 55-Rs. 200, age-dependent) and the Central Government matches it, providing an assured Rs. 3,000/month pension after age 60, requiring consistent payments until 60 years of age, with options to revive if payments lapse.

These Departments are further required to nominate their Nodal Officer who shall coordinate and share registration related information in the specified proforma with Labour Department, GNCTD, Nodal Officer Sh. Shashi Bhushan on his mobile/whatsapp/e-mail on daily basis.

Dear Chief Secretary,

As you are aware, the Ministry of Labour & Employment is implementing the Pradhan Mantri Shram Yogi Maañdhan (PM-SYM) Scheme, aligned with the vision of the Hon'ble Prime Minister to achieve cent percent coverage of eligible beneficiaries and bring them under the social security net of pension.

2. To further strengthen pension coverage, the Ministry of Labour & Employment conducted a special drive from 25th August to 15th September 2025. Considering the overwhelming response received, it has now been decided to launch a nationwide Special Registration Drive in a phased manner for the PM-SYM and NPS-Traders schemes, leveraging Panchayati Raj Institutions (PRIs), Urban Local bodies and Common Services Centres (CSCs) on below mentioned dates:

Phase I : Urban Areas

Duration: 15th January–15th February, 2026

Phase II : Rural Areas

Duration: 16th February–15th March, 2026

3. The camps will be organised at Panchayat Raj Institutions (Zilla Parishad, Block Panchayat and Gram Panchayat) Urban Local Bodies (Nagar Nigam, Nagar Palika, Nagar Parishad) Collectorate, Zila Parishad, Tehsil, BDO offices, with active support from CSC-VLEs and local governance institutions in high-potential States/Districts/Blocks with a significant unorganised worker population. These camps will facilitate on-the-spot enrolment and substantially enhance beneficiary coverage.

4. The primary objective of the campaign is to take the schemes to the grassroots level and bring unorganised workers under the safety net of social security.

5. In this regard, you are requested to issue necessary instructions to the State Urban Development, Rural Development and Panchayati Raj Departments, all District Magistrates/Deputy Commissioners, CEO ZPs and the State Labour Department to organise the Special Registration Drive during the above period and to share **daily progress reports** with the Ministry of Labour and Employment in the format placed at **Annexure-I**.

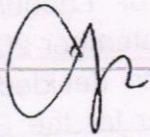

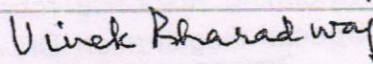

- States/UTs need to bifurcate the State targets provided by the Ministry between the Districts for fulfilling the targets within the stipulated timeline. (Action: States/UTs)

2. Training & Awareness

- Use CSC's digital platforms and WhatsApp groups to spread awareness. (Action: MoLE)
- Launch awareness campaigns via Local newspapers, WhatsApp groups, Gram Sabha announcements. (Action: States/UTs)
- Distribute pamphlets and posters in rural areas. (Action: States/UTs)

3. Camp Execution

- Organize registration camps at Gram Panchayat level with the support of PRIs and VLEs. (Action: MoPR & CSC)
- Enable on-the-spot registration through CSCs. (Action: MoLE & MoPR)
- Ensure presence of Labour Department officials for grievance redressal. (Action: MoLE)
- Officers to share daily progress of their State/Districts on Maandhan portal. (Action: States/UTs/CSC to develop a page for daily monitoring)
- Share social media updates and success stories. (Action: States/UTs & MoLE)
- Collect feedback from beneficiaries and PRI members for continuous improvement. (Action: States/UTs)
