OFFICE ORDER

Sub: Validity of CCA/CTO/Authorization- reg

In partial modification of the Office Order issued vide No. WB/G-295/21-22/147 Dated Guwahati, the 17th December 2022 & WB/G-295/21-22/419 dated Guwahati, the 27th May, 2024; the Board has decided that renewal of CCA/CTO/Authorization for Stone Crushing Units and LAMC Bee Hive Coke Oven/Crushing Units may be granted for a period of either one (1) year or five (5) years, subject to strict compliance with the conditions stipulated by the Board.

Further, all Stone Crushing Units shall mandatorily submit GST No Dues Certificate on an annual basis on June every year for the previous financial year to ensure compliance with the GST-related requirements of the competent tax authorities while maintaining statutory consent timelines as per Air (Prevention and Control of Pollution) Act, 1981, Water (Prevention and Control of Pollution) Act, 1974 and Environment (Protection) Act, 1986 in accordance to the Board's earlier Notification vide No. TECH-15/9/2026-CCA-PCBA/2 Dated Guwahati, the 11th March, 2026. However, submission or acceptance of such certificate by the Board shall not, in any manner, be construed as verification, endorsement, or certification of GST compliance by the Assam Pollution Control Board.

This Notification is issued with the approval of the competent authority and shall come into force with immediate effect.

The matter is subject to post-facto approval of the Board.
