ORDER:

In the G.O. 1<sup>st</sup> read above, Notification was issued appointing the Officers of the Labour Department as Conciliation Officers, Authorities, Appellate Authorities etc., under various Labour Acts.

2. In the references 2<sup>nd</sup> to 5<sup>th</sup> read above, Labour Codes have been enacted repealing the Central Labour Laws in implementation.

3. In the reference 6<sup>th</sup> read above, the Government of Andhra Pradesh enacted the State Labour Laws viz., 1. Andhra Pradesh Shops and Establishments Act, 1988 (Act No. 20 of 1988) 2. Andhra Pradesh Factories and Establishments (National festival and other Holidays) Act, 1974 (Act No. 32 of 1974) 3. Andhra Pradesh Labour Welfare Fund Act, 1987 (Act No. 34 of 1987) which contain the provisions for appointment of Registering Officers, Appellate Authorities and Inspectors.

4. Government after careful examination, decided to supersede all the previous notifications issued in this regard relating to designating officers of labour department to discharge functions under various labour laws as previously notified and issue fresh notification appointing the officers of the Labour Department as Registering Officers, Conciliation Officers, Cess Collectors, Cess Assessment Authorities, Certifying Authorities, Licensing Authorities, Appellate Authorities and Inspectors-cum-Facilitators under the Labour Codes and Registering Officers, Inspectors, Authorities, Compounding Officers under the State Labour Laws.

5. Accordingly, the following notification shall be published in the next issue of the A.P. Gazette.

NOTIFICATION

In exercise of the powers conferred by

1. Section 7, Section 4, Section 19(1), Section 31(3), Section 39(1), Section 45, Section 49, Section 51 and Section 56 of the Code on Wages, 2019 (Central Act No.29 of 2019);

2. Section 3, Section 4, Section 34 (1) (5) & (6), Section 46, Section 47 (1), Section 57 (2a), and Section 119(6) of the Occupational Safety, Health and Working Conditions Code 2020 (Central Act No.37 of 2020);
3. Section 5, Section 29, Section 32 and Section 43 of the Industrial Relation Code 2020 (Central Act No.35 of 2020);
4. Section 56 (8), 57(3), 58 (1), 91 (1), 100 (1), 103 (2), 105 (1), 106 of the Social Security Code, 2020 (Central Act No.36 of 2020);
5. Sections 3, 6, 48(1), 48(3), 50, 53, 57 of the Andhra Pradesh Shops and Establishments Act, 1988 (Act No. 20 of 1988)

and in supersession of all previous notifications issued under the Central Labour Laws which stand repealed and subsumed by the aforementioned 4 (Four) Codes and in modification of the notifications issued under the State Labour Laws read above, the Governor of Andhra Pradesh hereby appoint the officers mentioned in Column (2) of the Annexure to this Order to discharge the functions mentioned at column (4) thereof under the above mentioned Labour Codes for the "**Whole of the State of AP**", subject to the stipulations in the Note appended to the Annexure:

Note: 1. The above mentioned Officers shall exercise their powers and discharge their functions in the geographical area over which they have administrative jurisdiction, as per Annexure 1 (Memo No. M/6139/2014 Dt.27.09.2014 of the Commissioner of Labour), which may be streamlined/modified from time to time with the approval of Government. As and when the circumstances warrant, any of the subordinate officers can exercise jurisdiction anywhere in the State, as authorized by the Commissioner of Labour; anywhere in the Zone as authorised by the respective Joint Commissioner of Labour; anywhere in the District as authorised by the respective Deputy Commissioner of Labour and anywhere in the geographical jurisdiction of the respective Assistant Commissioner as authorised by him/her.

2. Registration of Establishments shall be through the dedicated Web Portal of the State Labour Department and the respective ALO/ACL/DCL/JCL under whose jurisdiction the Establishment is located shall be mapped as Registering/Licensing Officer.
3. The Joint Commissioners of Labour and above ranked Officers can also take up any claims under the above Acts irrespective of the pecuniary limits, if the circumstances warranting such action are recorded in writing and reported to the Commissioner of Labour.
4. The Conciliation Officers shall take up Industrial Disputes in Industries as specified below:
  - (a) Assistant Commissioners of Labour: Collective Disputes in Industrial Establishments employing up to 100 workers (including Contract Labour); individual disputes in all Industrial Establishments irrespective of number of employees employed in the establishment.
  - (b) Deputy Commissioners of Labour: Collective Disputes in Industrial Establishments employing Above 100 and up to 300 workers (including Contract Labour)

(c) Joint Commissioners of Labour (Zone Heads): Collective Disputes in Industrial Establishments employing Above 300 workers (including Contract Labour)

(d) Additional Commissioner of Labour: Collective Disputes in Establishments having branches or units in more than one Zone.

(e) Additional Commissioner of Labour and the Joint Commissioner of Labour in the office of the Commissioner of Labour: Any industrial dispute as may be assigned by the Commissioner of Labour.

(f) Officers in the cadre of Joint Commissioner of Labour and above shall take up any dispute irrespective of number of workers as and when required. The lower officers in the concerned Zone, shall also take up any Industrial Dispute assigned to them by the Joint Commissioner of Labour and above irrespective of number of workers.

5. Claims under Section 45 of the Wages Code for an amount below Rs.50,000/- shall be heard by the Assistant Commissioner of Labour; Rs.50,000/- to Rs.2 Lacs by the Deputy Commissioner of Labour and above Rs.2 lacs by the Joint Commissioner of Labour. In case of contingency of higher officers taking up the Claim under Section 45, the next higher Officer shall be the Appellate Authority under Section 49.

6. The Inspections as assigned by the Government from time to time vide G.O.Ms.No.27 Dt.31-5-2016 read with G.O.Ms.No.24 Dt.4-11-2025 and other relevant GOs.; are subject to the exemptions granted by the Government to shops and various categories of establishments from all or any of the provisions of the Andhra Pradesh Shops and Establishments Act, 1988 and under other Andhra Pradesh Labour Laws and the Andhra Pradesh Rules under the Central Labour Laws / Labour Codes notified by the Central Government; and regulated by the Government instructions in force based on the Policy and instructions on Online Inspections, Self Certification and Third Party Audit and other Policies notified by the Government.

7. Fatal Cases under the Employee Compensation cases (as per Chapter VII of Code on Social Security (36 of 2020)) are to be dealt with by the Assistant Commissioners of Labour and the Non-Fatal cases by the Deputy Commissioners of Labour.

8. Assistant Labour Officers are appointed to register the Building and Other Construction workers as beneficiaries as per Section 106 as authorised by the Andhra Pradesh Building and Other Construction Workers Welfare Board, constituted under Section 7 of the Code on Social Security (36 of 2020)

9. Joint Commissioners of Labour and above categories are assigned the Cess Assessment Officer if the cost of construction involved is above rupees 5 crores; Deputy Commissioners of Labour in respect of rupees 1 crore up to 5 crores; and Asst. Commissioners of Labour up to rupees 1 crore
