Taking into account of the above references and in continuation to this office Circular and Memo No. G.40(Misc)R.Min dated 10/10/2023, 09/11/2023, 06/11/2023 and Circular No. P(Misc)/Flameproof/23 dated 08/07/2024 and 24/03/2025 respectively, it may be noted that CNG/CBG compressor package, used for filling of gas cylinders and for dispensing as automotive fuel installed in the premises covered under license Form-E & F and Form-G of the said Rules were kept in abeyance from obtaining approval from the O/o Chief Controller of Explosives, Nagpur upto 30/09/2025 and it is hereby extended upto 31/03/2026 subject to following conditions:

1. All Ex-electrical components installed in the CNG/CBG compressor shall be approved by the Chief Controller of Explosives and the approval shall be valid as on date.
2. An undertaking that all the electrical components installed in the CNG/CBG compressor are of the type approved by the Chief Controller of Explosives shall be submitted prior to grant/amendment (if applicable) of the license as well as during inspection of the premises.

Meanwhile, the compressor manufacturers are advised to obtain approval from this office for their compressor packages on or before 31/03/2026.
