1. The Explosives Act, 1884
2. Explosives Rules, 2008;
3. Gas Cylinders Rules, 2016;
4. Static and Mobile Pressure Vessels (Unfired) Rules, 2016;
5. Petroleum Rules, 2002;
6. Ammonium Nitrate Rules, 2012; and
7. Calcium Carbide Rules, 1987.

Suggestions are invited from all stakeholders, including industry associations, manufacturers, importers, exporters, OMCs, private entities, testing and inspection agencies, academia, government departments and other interested persons.

Stakeholders are requested to submit specific, evidence-based, and practical suggestions by 31.07.2026, preferably separately for each provision, along with justification.

Suggestions should include:

- Section/Rule/Sub-rule/Clause/Schedule/Form, as applicable;
- Existing provision;

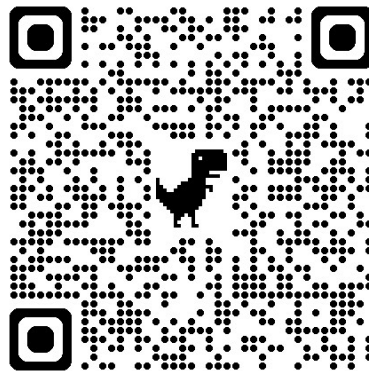
- Proposed amendment;
