## NOTIFICATION

Whereas, certain draft rules, which the Department of Tourism, UT Administration of Dadra & Nagar Haveli and Daman and Diu proposed to make in exercise of the powers conferred by sub-section (1) of section 42 of the Dadra & Nagar Haveli and Daman and Diu Registration of Tourist Trade Act, 1982.

And whereas, the Administration considers it expedient to amend certain conditions prescribed for Bed & Breakfast / Homestay Establishments (E Category) with a view to promote ease of doing business and to encourage wider participation in the tourism sector;

Now, whereas, in exercise of the powers conferred by sub-section (1) of section 42 of the Dadra and Nagar Haveli and Daman and Diu Registration of Tourist Trade Act, 1982, the Administrator of Dadra & Nagar Haveli and Daman & Diu is pleased to frame the Goa, Daman & Diu Registration of Tourist Trade (3rd Amendment) Rules, 2026.

Now, therefore, the Department of Tourism, DNH & DD, hereby publishes the draft of the Goa, Daman & Diu Registration of Tourist Trade (3rd Amendment) Rules, 2026 for inviting objections and suggestions if any, in writing to the Director-cum Joint Secretary (Tourism), 4<sup>th</sup> Floor, Vidhyut Bhavan, Secretariat, Daman from all persons likely to be affected thereby on or before the expiry of 30 days

### **DRAFT NOTIFICATION**

1. Short title and commencement -

(1) These Rules may be called the Goa, Daman & Diu Registration of Tourist Trade (**3<sup>rd</sup> Amendment**) Rules, 2026.

2. Amendment in rule -3:- In Rule 3 of the Goa, Daman and Diu Registration of Tourist Trade Rules, 1985 (herein after call the principal rules) the following shall be amended:

i. In Rule 3 (1) - the fees for registration for following categories is amended as follows:

| Category            | Fees (Per Year)                                                                                                                                   |

| (ii) Hotel-Keeper   | ‘A’ Category - Rs 50,000/-<br>‘B’ Category - Rs 40,000/-<br>‘C’ Category - Rs 30,000/-<br>‘D’ Category - Rs 20,000/-<br>‘E’ Category - Rs 5,000/- |
| (iii) Travel Agents | a. Rs 5,000/- conforming to standards laid down in Rule 9<br>b. Rs 2,000/- for other travel agents like- excursion agents, tourist guides etc.    |

- ii. In Annexure “A” (Part-E) of Rule 3 Bed & Breakfast / Homestay Establishment (“E” Category), the condition namely **“The Owner/promoter of the Establishment alongwith his/her families is physically residing in the same establishment in the suitable locality,”** shall be omitted.
- iii. In Annexure “A” (Part-E) of Rule 3, under point (b), for the words **“Minimum one lettable room and maximum 6 rooms”** the words **“Minimum one lettable room and maximum 8 rooms”** shall be substituted.

- iv. In Annexure “A” (Part-E) of Rule 3, after point (j), a new point (k) will be inserted as **“(k) The documents required for the registration of the Homestay / Bed & Breakfast will be as decided by the prescribed authority.”**
- v. In Rule 14 (2) - the fees for registration of persons carrying on business of plying boats is amended as follows:
