In exercise of the powers conferred under Section 53 of the Legal Metrology Act, 2009 the Government of Tripura hereby makes the following rules further to amend the Tripura Legal Metrology (Enforcement) Rules, 2011, namely: -

**THE TRIPURA LEGAL METROLOGY (ENFORCEMENT) (2<sup>ND</sup> AMENDMENT)  
RULES, 2026**

**1. Short title, extent and commencement.** -(1) These rules may be called "the Tripura Legal Metrology (Enforcement) (2nd Amendment) Rules, 2026";  
(2) They shall come into force on the date of their publication in the Official Gazette.

**2. Amendment of Rule 11:** For rule 11 of the Tripura Legal Metrology (Enforcement) Rules, 2011, (hereinafter, called the principal rules) the following rule shall be substituted, namely: -

**"11. Licensing of manufacturer, repairer and dealer of Weights and Measures-**

(1) Every manufacturer, repairer or dealer of weights & measures shall make an application to the Controller or such other officer for issuing licenses as may be authorized in this behalf, online, on such portal as may be specified by the State Government by issuing notification in the official Gazette.

(2) Fees for issuance of licence as specified in Schedule -IV shall also be paid online in the said portal.

(3) The form of online application shall be such as specified in schedule-IIA.

(4) Every licence issued to the manufacturer, repairer or dealer shall be in the appropriate form as specified in schedule-III.

(5) The Controller or such other officer as may be authorized by him in this behalf, shall maintain a register of licensed manufacturers, dealers and repairers in the form as specified in Schedule V.

(6) Every licence issued under this Act shall be displayed in a conspicuous place in the premises where the licensee carries on business.

(7) A licence issued under this Act shall neither be saleable nor transferable. "

**3. Amendment of Rule 12:** For sub-rule (1) of the Principal Rules, the following rule shall be substituted, namely: --

"(1) The Controller or such other officer authorized by him in this behalf may, if he has any reasonable cause to believe that the holder of any licence issued or continued under this Act has made any statement in, or in relation to, any application for the issue or

continuance of the licence which is incorrect or false in any material particular or has contravened any provision of the Act or any rule or order made there under, suspend such licence, pending the completion of any inquiry against the holder of such licence

Provided that no such licence shall be suspended unless the holder thereof has been given a reasonable opportunity of showing cause against the proposed action:

Provided further that where the inquiry referred to in this sub-section is not completed within a period of three months from the date of suspension of a licence, such suspension shall, on the expiry of the period aforesaid, stand vacated."

**4. Omission of Rule 13:** Rule-13 of the Principal Rules is hereby omitted.

**5. Amendment of Rule 14:** For rule 14 of the Principal Rules, the following rule shall be substituted, namely: -

**"14. Verification of weights or measures:** Every person seeking verification and stamping of weights and measures used for commercial purposes shall apply in such manner as may be specified by the state government by issuing Notification in the official Gazette."

**6. Amendment of Rule 17:** In rule 17 of the Principal Rules, after sub-rule (3), the following sub-rule shall be inserted, namely: -

"(4) In the event of any shortfall in collection of fees on account of oversight, the controller may issue such directions to such officers, as may be required for the purpose of realizing the same."

2. Every condition prescribed after the issue of this licence shall, if notified in the official Gazette, be binding on the person to whom the licence has been granted."
