### **ORDER:**

The Hon'ble Minister for Labour Welfare and Skill Development has made the following announcement on the floor of the Tamil Nadu legislative Assembly on 09.04.2025: -

Based on the above announcement, in the letters second read above, the Director of Labour has sent the proposal for providing the educational assistance to the children of registered Construction Workers of the Tamil Nadu Construction Workers Welfare Board studying Diploma in Nursing and Diploma in Catering and Services.





**AMENDMENT.**

In the said Scheme, in clause 15, in sub-clause (1), in the TABLE, in column (3) against Serial number 10 in column (1) thereof, for the expression "Studying ITI or Polytechnic Courses (Every academic year)", the expression "Studying ITI or Polytechnic Courses or Diploma Course in Nursing or Diploma Course in Catering and Services" (Every academic year)" shall be substituted.


