

5. Separate list of Holidays will be published by the Commissioner of Public Instructions for the Education Department.
6. In addition to the General Holidays the State Government Employees may utilize any of the restricted holidays not exceeding two days during the year 2019 with prior permission from the authority who is authorized to sanction Casual Leave.


