Whereas the General re-poll Election to Lok Sabha at 88-Asaoti polling stations of 85 Prithla Assembly segment of 10-Faridabad Parliamentary Constituency in the State of Haryana to be held on **19.05.2019 (Sunday) from 7.00 A.M. to 6.00 P.M.** as intimated by Chief Electoral Officer, Haryana vide letter No. 220/Re-poll/LS/Elec-2019/2AE-6757 dated 15.05.2019.

And whereas, it is considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, **the Governor of Haryana hereby fixes "Sunday" the 19.05.2019 to be a close day (holiday)** for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana only for their employees who are enrolled as voters in 88-Asaoti polling stations of 85 Prithla Assembly segment of 10-Faridabad Parliamentary Constituency to enable them to exercise their franchise.
